FAIR GROUNDS PROFESSIONAL USE POLICY

CAMPGROUND USER FEES:

- RV Hook-up \$20/night
- Dry Camping \$15/night

User responsibilities:

- ✓ Premises will be left in as good or better condition than when first occupied.
- ✓ All trash picked up. Trash cans emptied into dumpsters.
- ✓ NO unattended animals.
- ✓ Stall fees of \$10/horse and the camping fees, shall be collected by group users and paid to the Benewah County Fair Association.
- ✓ NO horses in camping areas
- ✓ Manure must be scooped out of stalls and piled in front of gates. DO NOT throw over fence behind!

Campground use will be on a first come, first serve basis. Exceptions to this are the weekend prior to the fair and the week of the fair. At that time you may be asked to vacate if you are not involved with the fair. User fees should be paid prior to campground use. Campground stays are limited to 5 days unless prior arrangements are made with the groundskeeper. Camping fees will be monitored.

ARENA FEES

- Full day use (Includes tractor work & water before, once during event, and after event) \$200/day
- Half day use (Includes tractor work & water before and after event) \$100/day
- Youth/4-H Activities are exempt

Extra tractor work will be \$50/use

ENTIRE FAIRGROUNDS INCLUDES: Upper Parking Lot, ALL USEABLE BUILDINGS; Walker Building w/kitchen, McLean Barn, Jon Denny Building, Judd Barn and campground.

- Entire fairgrounds \$500/day + Camp Fees
- Entire fairgrounds w/ arena \$650/day + Camp Fees
- Entire fairgrounds w/arena worked and watered \$850/day + Camp Fees

Events that use the whole fairgrounds are on a case by case basis. Please contact the fair board secretary to get on the agenda.

Large horse events must place a \$1000 deposit. Failure to clean up stalls and horse waste require extra hours for our staff. That time will be deducted from the deposit.

Professional use refers to use when money is being made and or collected.

KEYS: Keys will be picked up and returned to: ***Kim Dixon, who lives on the fairgrounds*** (Keys will not be given out unless payment has been made)

- Scheduling will be done on a first come, first serve basis.
- Judd Building: Individuals and professional training activities where money is collected – \$100

/day & \$75 Half day or less will be charged.

LIABILITY WAIVER: The undersigned agrees to indemnify and hold harmless the Benewah County Fair Board, Benewah County and the City of St. Maries from and against all claims, damages, losses and expenses arising out of any action, omission, or event which causes bodily injury, illness, death or property damage caused in whole or in part by the applicants or their animals use of the Benewah County Fair Grounds.
